"Food, Livelihood and Healthcare for All"

A public welfare programme for providing water for the marginalized population was carried out in the State of Odisha under FCRA component with financial assistance provided by an international voluntary organization, Sewachild International, California, USA, represented by Mr. Rick Carlton, President of the organization, which is also represented in India by Mr. Ankush Mehra, Director (India Operations), situated in Delhi. The work of submersible water hand pump was undertaken for the welfare of the villagers of __ within __ district, in the State of Odisha in the month of July, 2022.













The water table in this region is very low and the villagers had to fetch water from far off places. The water is usually carried by the women and the girl child who are required to devote larger part of the day and their lives in fetching water for their families for carrying out household chores as also for cooking, drinking and bathing. This tube well proved to be a boon for the poor families in this region.







"Food Benefit Programme for the Aged and Destitute" at Vrindavan, Mathura, Uttar Pradesh State, India (Financial Year 2022-23)

A Food Benefit Programme was organized by Socio Economic Research Institute, a voluntary organization in India, through financial assistance provided by SevaChild International, California, USA, represented by Mr. Rick Carlton in the US and Mr. Ankush Mehra, the India representation of SevaChild International. The programme was held at Vridha Ashram (abode for the aged) on **18**th **August, 2022**, which also happened to be the day of the incarnation of Lord Krishna.

The members of our organization and our volunteers had planned the programme well in advance and had made all the necessary arrangements for the procurement, informing the locals and logistics-related activities so that the needy could get the desired benefits. Necessary arrangements for storage, deployment of staff, publicity and documentation were in place so that the people could easily benefit from the programme.

On 18.08.2022, the programme started late in the evening at around 4.30 p.m. (IST) and went on till 10.00 p.m. (IST) in the night, as it also happened to be a national holiday and a festival of the birth of Lord Krishna in Mathura, his birthplace. The beneficiaries were very happy and satisfied with getting the much-needed livelihood package. They also requested our organization to hold such programmes in the future, as well.







On this occasion, Ration Food Packets (kits) containing daily use rations, groceries, toiletries, sanitary napkins and surgical masks were distributed amongst the beneficiaries, free of cost. The beneficiaries were pre-identified by our volunteers and the need-based requirements were taken into account to carry out the benefit programme.







The beneficiaries basically comprised the members of the Ashram and other poor category women-folk who graciously received the kits and also expressed their gratitude towards the SevaChild International, USA and our organization, SERI, New Delhi.

The ration kits were sufficient for a family of four members to sustain their livelihood for a period of 28 days. In the case of the aged population who were alone, the ration supplies were enough to sustain them for longer durations. The beneficiaries constituted the sections of the

society who could not avail of the benefits from various State Government-sponsored programmes owing to various reasons. Mr. (Prof.) Rakesh Sharma, Dean, College of Engineering from GLA University, Mathura, State of Uttar Pradesh, a devotee of Lord Krishna and a volunteer of our organization also participated in the programme.







The beneficiaries were in real need and requirement of these ration kits keeping in view their vulnerable conditions and non-access to the various government schemes. A total of 200 beneficiaries were given the Ration Food Packets (kits) and the programme was documented through still and video coverage by our volunteers.







We, on behalf of our organization, would like to extend our gratitude to Mr. Rick Carlton, SevaChild International, California, USA and its India Representative Mr. Ankush Mehra, for their unconditional, continuous and timely support and cooperation to us in various humanitarian and beneficial programmes and activities in India.

Mr. Rick Carlton and Mr. Ankush Mehra are doing exceptionally excellent work through SevaChild International in the field of humanitarian sustainable initiatives not only in India but globally, as well.

"MALNUTRITION PREVENTION PROGRAMME - 2022"

Organized by: SERI Trust, New Delhi, India Supported by: SevaChild International, USA





A Malnutrition Prevention Programme was undertaken in Resettlement Colony in Jahangirpuri locality situated in North District of NCT of Delhi, India, on **07**th **August 2022**. This area largely comprises industrial workers and low-income groups with meager sources of livelihood. These people had migrated from various parts of the country in search of employment. The area is surrounded by slum clusters as well. Our organization carried out the free-of-cost distribution of Ration Food Packets (Kits) donated for this noble and social cause by SEVA CHILD INTERNATIONAL, California, USA, represented by Mr. Rick Carlton and by Mr. Ankush Mehra in India. We express our heartiest gratitude to the voluntary organization, its representatives, workers & Mr. Ankush Mehra, who have been instrumental in providing the sustenance package to our organization, in the past as well.





Each Ration Food Packet (Kit) contained items, such as Cooking Oil (Mustard) (1 litre), Pulses (1 kg each; 2 types), Wheat Flour 10 kg), Poha (1 kg; 2 packets), Rava (1 kg), Rice (5 kg), Grounded Spices (200 gms each comprising Chili, Coriander & Turmeric), Tea Leaf (500 gms), Sugar (1 kg), Salt (1 kg), Toilet Soap (1 no.), Sanitary Pads (3 nos.) and Face Masks (2 nos.). The total number of beneficiaries who were distributed the relief package was around 200. Most of the beneficiaries included housewives and the aged population. The beneficiaries were happy to receive the relief package that would last for around 25 days a month. The pandemic that engulfed the population, the world over, during the last two years has left an indelible mark on the lives of many people, especially those who belong to marginal sections of society and also those who have erratic sources of earning a livelihood. Though these beneficiaries are working to earn a livelihood, they are without any work for at least 2-3 months in a year. This adversely affects their access to the basic needs of sustaining their lives and those of their family members.

The programme was held in a local park to prevent intrusion from outside. The general public was very supportive and managed themselves very well. They were very happy and expressed their heartfelt gratitude to the organizers and SevaChild International, USA, for providing them with relief material. The Ration Food package (kits) comprised grocery items, sanitary pads, and toiletries for their daily use which was sufficient to provide daily nutrition and hygiene to women-folk for a period of 25 days in a family comprising 4 members.





The benefit programme was also attended by the local representative of the people who looks after the needs of these beneficiaries. Our organization was in constant touch with these people and had been working to provide them with the Ration Food Packets, which have been provided by SevaChild International. We have been regularly receiving support and cooperation from SevaChild International, USA in our endeavour to provide some relief to such people belonging to marginalized section of the society.

The Relief Programme for free-of-cost distribution of Ration Food Packets (kits) started at around 10.30 am and went on till 4.00 p.m. on 07.08.2022. The location was selected as a nearby park which was also fenced and protected from outside disturbances. The programme went very well and everyone was happy to receive the kits.

Our organization is indeed thankful to Mr. Rick Carlton, representing SevaChild International, California, USA and Mr. Ankush Batra, the India Representative of SevaChild. We are also thankful to SevaChild International for their continuous support and cooperation in standing behind us in providing the relief materials as and when our organization has sought their help in such noble activities, anywhere in India.

A Preventive Healthcare Programme for Protection from Vector-Borne Diseases (VBDs), such as Malaria, Dengue, Chikungunya, etc., was organized by our organization, Socio Economic Research Institute (SERI), New Delhi, on 21st September, 2022 within Panruti taluka of Cuddalore district, Tamil Nadu.

This benefit programme was organized from the financial assistance provided by the Indian Oil Corporation Limited (IOCL), a Central PSU, under its CSR component.

Under this programme, 1000 Long Lasting Insecticidal Nets (LLINs), provided by HILNET (India) Limited, another CPSU, and distributed free-of-cost amongst the various socioeconomically weaker sections within Panruti taluka.

This programme was organized with the guidance of the Office of Hon'ble Member of Parliament, Shri TRV.S. Ramesh and other local political representatives and the local volunteers. The programme was held at Village & PO: Thirasu, Panruti Taluka, Cuddalore District, Tamil Nadu.

Shri V. Kumar, DGM (HR) – TNSO, the representative from IOCL, also graced the occasion with his presence and distributed LLINs amongst the beneficiaries.

The programme was attended by around 200 families, numbering around 600 during the day and was inaugurated by Shri V.K. Venkatraman, Union Secretary, Annagramam and Smt. Parvatham Venkatraman, Union Councillor, Panruti taluka, Cuddalore district. The distribution programme commenced at around 10.00 a.m. and went on till around 5.00 p.m. The concerned officer at the Primary Health Centre, Panruti, was also handed over around 400 LLINs to be distributed amongst the various patients/ beneficiaries belonging to weaker sections, the aged, women and physically challenged people.

Adequate seating, sanitation, drinking water arrangements were made for the beneficiaries, guests and volunteers at the venue.

The programme was also attended by the local print media and the news items appeared in the local dailies. The reporting by the media provides us the encouragement and support required for such interventions.

We are indeed thankful to the Hon'ble Member of Parliament, Shri TRVS. Ramesh (Cuddalore Parliamentary Constituency), the local political and public leaders, representative from the IOCL, the volunteers, Press and Media, for making this intervention possible. We are also thankful to the local population who gathered and made this programme a success. We are also thankful to the concerned authorities at the local Primary Health Centre, Panruti, for their help and support.

We endeavour to continue our benefit programme in other areas within Cuddalore Parliamentary Constituency with the aid and assistance from the local representatives, people and IOCL, in the future as well.

A two-day Public Preventive Healthcare Programme was organized by Socio Economic Research Institute, New Delhi (SERI), a voluntary organization engaged in carrying out various welfare and benefit programmes for the vulnerable sections of the society living in urban, semi-urban, rural and remote tribal areas of the country.

This benefit programme was provided financial assistance by NLC India Limited (NLC) to the voluntary organization under its CSR Initiative.

This public benefit programme was held at Government Higher Secondary School, Panruti Taluka of Cuddalore district, Tamil Nadu. The voluntary organization could organize this benefit programme only due to the blessings and guidance of the local people's representative, Shri TRV.S. Ramesh, Hon'ble Member of Parliament (Lok Sabha) from Cuddalore district. District Cuddalore also happens to be the Parliamentary Constituency of Hon'ble Member of Parliament, Shri TRV.S. Ramesh. It was on the intervention of the Hon'ble MP (LS) only that this benefit programme could be identified and initiated.

This public preventive healthcare programme was necessitated due to the vulnerability of Cuddalore district, as a whole, being prone to periodic spread of vector-borne diseases owing to the recurrent rains and floods in the area. These recurrent climate conditions cause accumulation of stagnant water which proves to be a breeding ground for the mosquitos causing vector-borne diseases.

These Long Lasting Insecticidal Nets (LLINs) are a sure method of prevention from mosquito bites, as these are coated with insecticides that are harmless to humans but are effective in prevention from mosquito bites, and thus prevent the spread of Vector-Borne Diseases (VBDs) such as Malaria, Dengue, Chikunguniya, Kalazhar, etc.

The LLINs come with three years of manufacturer's replacement warranty and can be washed every two to three months time period during its period of warranty and beyond, without affecting its insecticidal properties.



The programme was organized for free-of-cost distribution of Long Lasting Insecticidal Nets (LLINs) provided by the voluntary organization through HIL India Limited, another Central PSU, engaged in manufacturing insecticides and pesticides and other farming safety equipments in India.





The Inaugural Function of this benefit progrmame was held at the above venue on 16th December, 2022. The Hon'ble MP (LS), Shri TRV.S. Ramesh, could not attend the function due to the ongoing Parliament Session. In place of Shri TRV.S. Ramesh, **Shri K. Rajendiran, Chairman, Panruti Municipality and Shri A. Siva, Vice-Chairman, Panruti Municipality** attended this function. Apart from the local political representatives, **the representatives from NLC India Limited, Shri V. Ramachandran, CGM/ CSR, NLC India Ltd.**, the school administration, the local health department officers, amongst others, were present at this function.



The programme started at around 10.30 a.m. in the morning and during the course of the day, thousands of local beneficiaries, numbering around 2000, belonging to various marginalized and reserved categories attended this 2-day benefit programme. The programme went uptil 5.00 p.m. in the evening. A total of 8,800 LLINs were distributed during this two-day programme.

On this occasion, the dignitaries and the representatives of the voluntary organization distributed 2000 LLINs amongst the beneficiaries.

The hon'ble MP (LS), Shri TRV.S. Ramesh, owing to his non-availability at this programme, arranged to get distributed the remaining 6,800 through his party workers through house-to-house visits, within Panruti Taluka, because not all the beneficiaries could be distributed LLINs on that particular day.

The total number of beneficiaries was 8,800 who were distributed the LLINs, appeared to be happy and satisfied with this public preventive healthcare initiative of the voluntary organization and NLC India Limited.

The beneficiaries were pre-identified by the voluntary organization and the volunteers and the local youth were engaged for undertaking distribution of the LLINs amongst the beneficiaries. The beneficiaries were distributed these LLINs free-of-cost against presentation of the identity cards issued by the Government, such as, either Aadhar card, BPL card, etc.

The beneficiaries included the women, aged and vulnerable population within the Target Area. The following are some of the beneficiaries who were delivered the LLINs during house-to-house visits by the local party workers, as per the directions of the Hon'ble Member of Parliament (LS), Shri TRV.S. Ramesh, owing to his inability to attend the public benefit programme. The beneficiaries were located within Panruti taluka of Cuddalore district, Tamil Nadu.

The beneficiaries appeared to be very much satisfied and cheerful in receiving the LLINs as these would go a long way in combating the menace of water and vector-borne diseases, which are a recurring threat.



A proper documentation was carried out by the voluntary organization by compiling it in the form of still photography, videography, copies of the IDs submitted by the beneficiaries and their endorsements of the receipt of the prevention material, LLINs. The representatives of NLC India Limited were very much satisfied with the activities carried out by the voluntary organization during this two-day benefit programme.

A total 2000 numbers of beneficiaries were distributed the LLINs, which shall be useful for them owing to the stagnant water bodies which are a breeding ground for mosquitos. The district is prone to water and vector-borne diseases as it receives periodic and recurrent rainfall and floods due to its geographical location.









The local representatives and the beneficiaries appeared to be enthusiastic with the public healthcare programme carried out by the voluntary organization, under guidance of the local political representatives and the funding organization, NLC India Limited. The beneficiaries expressed their desire to hold such benefit programmes in future as well.

The beneficiaries expressed their gratitude and satisfaction for a unique public healthcare benefit programme implemented by our organization, through financial assistance from NLC India Limited, under the able guidance and blessings of Shri TRV.S. Ramesh, Hon'ble Member of Parliament (Lok Sabha) from Cuddalore Parliamentary Constituency, Tamil Nadu.

A two-day Health Camp Programme was organized by Socio Economic Research Institute, New Delhi (SERI), a voluntary organization engaged in carrying out various welfare and benefit programmes for the vulnerable sections of the society living in urban, semi-urban, rural and remote tribal areas of the country.

This preventive healthcare product against prevention from vector-borne diseases is not available in the market and is a unique product being procured and distributed by our organization free-of cost amongst the poor beneficiaries.



The details of the beneficiaries were registered prior to undertaking the basic screening, monitoring and distribution of health supplements at the venue.



This benefit programme was provided financial assistance to the voluntary organization by **RAILTEL Limited under its CSR Initiative**.



Adequate arrangements for Shamiana and Daris were made for the beneficiaries for waiting at the time and before registration for carrying out the basic health camp.



This public preventive healthcare programme was necessitated due to the vulnerability of the Target Area, as a whole, being prone to mal-nutrition related ailments, especially the women, children, differently abled and poor segments of the society. Our priority segment shall be on adolescent girls,

expectant and lactating mothers, old and weak, differently abled and the poor population, amongst others. The intervention included free of cost distribution of nutritional supplements and screening of basic health conditions and referrals to the district hospital, as the case may be or if required.











This Free health camp programme was held at Middle School premises in Chaurma within Islampur Block of Nalanda district, Bihar. The voluntary organization could organize this benefit programme only due to the blessings and guidance of the local people's representative, Shri Kaushlendra Kumar,

Hon'ble Member of Parliament (Lok Sabha) from Nalanda district. District Nalanda also happens to be the Parliamentary Constituency of Hon'ble Member of Parliament, Shri Kaushlendra Kumar. It was on the intervention of the Hon'ble MP (LS) only that this benefit programme could be identified and initiated. Adequate arrangements for tea and refreshments to the medical staff as also tea and snacks for the beneficiaries were made at the venue. Ambulances was also arranged for the beneficiaries in case of any emergency.





Apart from the hon'ble MP (LS), various other local area representatives, school administration, district administration and local health department representatives were also present during this programme.



The programme started at around 10.30 a.m. in the morning and during the course of the day, thousands of local beneficiaries, belonging to various marginalized and reserved categories attended this one-day benefit programme. The programme went uptil 5.00 p.m. in the evening.





On this occasion, the Chief Guest and other dignitaries and the representatives of the voluntary organization distributed free nutritional supplements to the beneficiaries and the basic health check up activities were undertaken by the district medical and para medical staff. The Chief Medical Officer, District Health Department, Nalanda, was also present during this occasion. The local department of health services was instrumental in extending a helping hand to our volunteers.





As per the report of the CMO, Public Health Centre, Islampur, Nalanda, a total number of approximately 2500 beneficiaries were screened for basic health checkups and were distributed nutritional supplements. The beneficiaries consisted of women, children, old and ailing, physically handicapped and other general population belonging to poor and reserved categories from Islampur taluka. The screening and monitoring was carried out for Hypertension and Diabetes and medicines were distributed for Fever & Cough, amongst other ailments to the beneficiaries.

The total number of beneficiaries was 2,500 (approx.) who were availed the benefit of health camp, appeared to be happy and satisfied with this public healthcare initiative of the voluntary organization and RAILTEL Limited.



The beneficiaries were pre-identified by the voluntary organization and the volunteers and the local youth were engaged for undertaking distribution of the supplements amongst the beneficiaries. The beneficiaries were distributed these supplements and also undertaken basic health check-ups, free-of-cost, against presentation of the identity cards issued by the Government, such as, either Aadhar card, BPL card, etc.

A Public Preventive Healthcare Programme was organized by Socio Economic Research Institute, New Delhi (SERI), a voluntary organization engaged in carrying out various welfare and benefit programmes for the vulnerable sections of the society living in urban, semi-urban, rural and remote tribal areas of the country.



This benefit programme was provided financial assistance to the voluntary organization by **RITES Limited under its CSR Initiative**.

This public preventive healthcare programme was necessitated due to the vulnerability of the Target Area, as a whole, being prone to periodic spread of vector-borne diseases. The menace of Malaria and other vector and water-borne diseases is recurrent in various parts of India caused by accumulation of stagnant water, a breeding ground for the mosquitos causing vector-borne diseases.







These Long Lasting Insecticidal Nets (LLINs) are a sure method of prevention from mosquito bites, as these are coated with insecticides that are harmless to humans but are effective in prevention from mosquito bites, and thus prevent the spread of Vector-Borne Diseases (VBDs) such as Malaria, Dengue, Chikunguniya, Kalazhar, etc.







The LLINs come with three years of manufacturer's replacement warranty and can be washed every two to three months time period during its period of warranty and beyond, without affecting its insecticidal properties.



The programme was organized for free-of-cost distribution of Long Lasting Insecticidal Nets (LLINs) provided by the voluntary organization SERI.







This public benefit programme was held at Middle School premises in Chaurma within Islampur block of Nalanda district, Bihar. The voluntary organization could organize this benefit programme only due to the blessings and guidance of the local people's representative, **Shri Kaushlendra Kumar**, **Hon'ble Member of Parliament (Lok Sabha)** from Nalanda district. District Nalanda also happens to be the Parliamentary Constituency of Hon'ble Member of Parliament, Shri Kaushlendra Kumar. It was on the intervention of the Hon'ble MP (LS) only that this benefit programme could be identified and initiated.
